“RESOLVED THAT Smt. Uma Jampana (DIN: 00912376) be and is hereby re-appointed as a Director of the Company, liable to retire by rotation.”

3. **TO CONSIDER THE SCHEME OF REDUCTION OF SHARE CAPITAL OF THE COMPANY.**

To consider and if, thought fit to pass with or without modification(s), the following resolution as a Special Resolution:

“RESOLVED THAT pursuant to Section 66 and other applicable provisions, if any, of the Companies Act, 2013 (“Act”) and the rules made thereunder including the National Company Law Tribunal (Procedure for Reduction of Share Capital of Company) Rules, 2016 (“NCLT Rules”) and any other applicable provisions of law (including any statutory amendment(s), modification(s) or re-enactment(s) thereof for the time being in force), the Articles of Association of the Company and subject to the confirmation by the Hon’ble National Company Law Tribunal, Hyderabad Bench (“NCLT”) and such other approvals, consents, permissions and sanctions as may be required to be obtained from appropriate Governmental authorities, departments, offices, institutions, bodies, agencies and/or third parties and subject to the terms and conditions, as may be prescribed while granting such approvals, consents, permissions and sanctions by the NCLT and/or any other appropriate Governmental authorities, departments, offices, institutions, bodies, agencies and/or third parties connected with the Reduction of Share Capital and which may be agreed to by the Board of Directors of the

Company ("Board") (which term shall be deemed to mean and include one or more committee(s) constituted/ to be constituted by the Board), approval of the members of the Company ("Members") be and is hereby accorded to the Scheme of Reduction of Share Capital ("Scheme") of the Company by way of reduction of paid-up share capital of the Company from Rs. 2,05,01,600/- (Rupees Two crores Five Lakhs One Thousand Six Hundred only) comprising of 1,02,50,800 (One Crore Two Lakhs Fifty Thousand and Eight Hundred Only) equity shares of Rs. 2/- each to Rs. 92,25,720/- (Rupees Ninety-Two Lakhs Twenty-Five thousand and Seven hundred Twenty only) divided into 46,12,860 (Forty-Six Lakhs Twelve Thousand Eight Hundred and Sixty) equity shares of Rs. 2/- each and such reduction would be effected by writing off the Accumulated Losses of Rs. 1,12,75,880/- (Rupees One Crore Twelve Lakhs Seventy-Five Thousand Eight Hundred Eighty Only) on the Effective Date of the draft Scheme of Reduction of capital ("Scheme").

RESOLVED FURTEHR THAT simultaneously with and as an integral part of the aforesaid reduction and re-organization of share capital, and pursuant to Sections 13, 14 and 61 of the Companies Act, 2013 and subject to approval of the Scheme of Reduction of Share Capital by the Hon'ble National Company Law Tribunal, Hyderabad Bench ("NCLT"), the Authorised Share capital of the Company be altered from Rs. 11,00,00,000/- (Rupees Eleven crores only) divided into 5,50,00,000 (Five Crores Fifty Lakhs only) Equity Shares of Rs.2/- (Rupees Two) each to Rs. 11,00,00,000/- (Rupees Eleven crores only) divided into 1,10,00,000 (One crores Ten Lakhs only) Equity Shares of Rs. 10/- (Rupees Ten) each and consequently the existing Clause V of the Memorandum of Association and Article 5 of the Articles of Association of the company be and is hereby altered by deleting the same and substituting in its place and instead thereof, the following:

"Clause V of Memorandum of Association:

"Clause V: The Authorised share capital of the company is Rs. 11,00,00,000/- (Rupees Eleven crores only) divided into 1,10,00,000 (One crores Ten Lakhs only) Equity Shares of Rs. 10/- (Rupees Ten) each."

Article 5 of Articles of Association:

"Article 5 : The Authorised share capital of the company is Rs. 11,00,00,000/- (Rupees Eleven crores only) divided into 1,10,00,000 (One crores Ten Lakhs only) Equity Shares of Rs. 10/- (Rupees Ten) each to be increased or reduced in accordance with the relevant provisions of Companies Act, 2013."

RESOLVED FURTHER THAT for giving effect to the reduction and consolidation, the entitlement of shareholders shall, subject to the Scheme and applicable laws, be determined such that for every 100 (One Hundred) equity shares of ₹2/- each held immediately prior to the Record date, the shareholder shall be entitled to 9 (Nine) equity shares of ₹10/- each after giving effect to the reduction and consolidation.

RESOLVED FURTHER THAT accordingly, upon the Scheme becoming effective, the total issued and paid-up Equity Share Capital of the Company shall stand reduced and consolidated from Rs. 2,05,01,600/- (Rupees Two crores Five Lakhs One-Thousand Six hundred only) comprising of 1,02,50,800 (One Crore Two Lakhs Fifty Thousand and Eight Hundred) equity shares of Rs. 2/- each, fully paid-up, to Rs. 92,25,720/- (Rupees Ninety-Two Lakhs Twenty-Five

Thousand Seven Hundred Twenty Only) divided into 9,22,572 Equity Shares of Rs. 10/- each, fully paid-up.

RESOLVED FURTHER THAT the aforesaid reduction of share capital shall be effected by cancellation and extinguishment of 56,37,940 (Fifty-Six Lakhs Thirty-Seven Thousand Nine Hundred Forty) equity shares of ₹2/- each, fully paid-up, and the said shares shall, upon the Scheme becoming effective and on the Record Date determined in accordance with the Scheme, stand cancelled, extinguished and rendered invalid, without any further act, deed or instrument on the part of the Company or the concerned shareholders, including by giving appropriate instructions to NSDL and CDSL, as applicable.

RESOLVED FURTHER THAT any fractional entitlement arising pursuant to the implementation of the Scheme (Reduction and consolidation) shall be dealt with in the manner provided in the Scheme and, where fractional entitlements are required to be rounded up to the next whole number, the corresponding increase in the number of equity shares arising from such rounding shall be foregone by Mr. Venkata Rama Mohan Raju Jampana, Promoter of the Company, so that the aggregate issued and paid-up share capital of the Company shall remain at Rs. 92,25,720/- (Rupees Ninety-Two Lakhs Twenty-Five Thousand Seven Hundred Twenty only) and shall not increase on account of such rounding-off.

"RESOLVED FURTHER THAT upon the Scheme becoming effective, in respect of shareholders holding equity shares in physical form on record date, the Company be and is hereby authorised to transfer and hold such shares in a Demat Suspense Account opened for this purpose, in accordance with the applicable provisions of law and the terms of the Scheme."

"RESOLVED FURTHER THAT it is noted that the proposed Scheme qualifies for exemption under Regulation 37(6)(b) of the SEBI (LODR) Regulations, 2015, being a scheme providing for writing off accumulated losses against the share capital of a listed company."

"RESOLVED FURTHER THAT subject to confirmation of the Scheme by NCLT and all other approvals from any other appropriate authorities, the Company shall not be required to add the words "And Reduced" to its name subsequent to such reduction of equity share capital of the Company."

"RESOLVED FURTHER THAT Board of Directors of the Company, or Company Secretary & Compliance Officer of the Company, be and are hereby severally authorised to do all such acts, deeds, matters and things; as may be considered requisite, desirable, appropriate or necessary to give effect to this resolution and effectively implement the proposed capital reduction including without limitation:

- (a) To finalize, amend and settle the draft Scheme, and assent to such alterations, conditions and modifications, if any, or effect any other modification or amendment as the Company may consider necessary or desirable to give effect to the Proposed Reduction thereof;
- (b) To file the Scheme and/or any other information/details with the Central/ State Government(s), SEBI, Stock Exchanges or anybody, authority or agency and to obtain sanction or approval to any provisions of the Scheme or for giving effect thereto;

- (c) To file any application, affidavit, petition, pleading, form or reports before Hon'ble NCLT or any other statutory or regulatory authority including the Registrar of Companies, the Regional Director or such other authority as may be required in connection with the Proposed Reduction or its sanction thereof and to do all such acts and deeds as they may deem necessary in connection therewith and incidental thereto;
- (d) To make any alterations/changes to the draft Scheme as may be expedient or necessary, which does not materially change the substance of the draft Scheme, particularly for satisfying the requirements or conditions imposed by the NCLT or any other appropriate authority;
- (e) To sign all applications, petitions, affidavits, undertakings, certificates, documents, letters relating to the Proposed Reduction and represent the Company before the NCLT and any other authorities in relation to any matter relating to the Proposed Reduction or delegate such authority to any other person through a valid power of attorney;
- (f) To verify, sign, deal, swear, affirm, declare, deliver, execute, make, enter into, acknowledge, undertake, record all deeds, declarations, instruments, vakalatnamas, applications, petitions, affidavits, objections, notices and writings whatsoever as may be usual, necessary, proper or expedient and all manner of documents, petitions, affidavits and applications under the applicable laws and to represent the Company in all correspondences, matters and proceedings and any nature whatsoever in relation to the above;
- (g) To obtain the requisite approval and/or consents of the shareholders, secured lenders of the Company, bank, financial institutions and other regulatory authorities as may be required and for that purpose, to initiate all necessary actions and to take other consequential steps as may be required from time to time in that behalf;
- (h) To engage any counsel, consultant firms, advocates, attorneys, pleaders, solicitors, valuers or any other one or more agencies, as may be required in relation to or in connection with the Proposed Reduction of share capital, on such terms and conditions as they may deem fit, finalize fees, terms and conditions of their appointment letter(s), furnish such information as may be required by them and also to sign, execute and deliver all documents, letters, advertisements, announcements, disclosures, affidavits, undertakings and other related documents in favour of the concerned authorities, advocates or any one or more persons as they may deem fit and to do all such acts, deeds and things as they may deem fit and as may be necessary in this regard;
- (i) To consider, approve, sign and execute all other documents, advertisements, announcements, disclosures, etc. which may be sent/required to be sent to concerned authorities on behalf of the Company;
- (j) To file requisite forms with the Registrar of Companies in connection with the Proposed Reduction during and after the process of sanction thereof;
- (k) To suspend, withdraw or revive the Scheme from time to time as may be specified by any statutory authority or as may be suo moto decided by the Board in its absolute discretion;
- (l) To approve such actions as may be considered necessary for approval / sanction by the NCLT or any other appropriate authority under the applicable provisions of the Act, including but not

limited to making filing with the concerned Registrar of Companies, Regional Directors, and other authorities as may be required, to approve all other actions required for full and effective implementation of the Proposed Reduction and do all such other acts, matters, deeds and things necessary, proper or desirable in connection with or incidental to giving effect to the purposes of this resolution;

- (m) To incur such other expenses as may be necessary with regard to the above transaction, including payment of fees to solicitors, merchant bankers, advisors, valuers, registrars and other agencies and such other expenses that may be incidental to the above, as may be decided by them;
- (n) To accept services of notices or other processes which may from time to time be issued in connection with the matter aforesaid;
- (o) To give such directions as they may think fit and proper, including directions for settling any questions or difficulties that may arise and to do all acts, deeds and tasks, as may be deemed necessary, expedient or proper to give effect to the proposed capital reduction and for matters connected therewith or incidental thereto.

EXPLANATORY STATEMENT

[Pursuant to Section 102 of the Companies Act, 2013]

ITEM NO.3: TO CONSIDER THE SCHEME OF REDUCTION OF SHARE CAPITAL OF THE COMPANY.

The proposed reduction of the equity share capital of Company is being undertaken in accordance with the provisions of Section 66 read with other applicable provisions, if any, of the Companies Act, 2013 ("Act") and the rules made there under and specifically the National Company Law Tribunal (Procedure for Reduction of Share Capital of Company) Rules, 2016 ("NCLT Rules"), which permit a company to undertake a reduction of its share capital in any manner and pursuant to Article 59 of Articles of Association of the Company, read with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") as amended from time to time, BSE Limited, subject to confirmation by the National Company Law Tribunal, Hyderabad Bench ("NCLT").

Background:

The Company was incorporated on 16th day of December, 1991 under the Companies Act, 1956. The Corporate Identification Number (CIN) of the Company is L26942TG1991PLC013564. The registered office of the Company is at Plot No.31, Sagar Society, Road No.2, Banjara Hills, Hyderabad- 500034, Telangana. The Equity shares of Company are listed on BSE Limited (BSE).

The proposed Reduction of Equity Share Capital of the Company will not have any adverse effect on the Creditors of the Company or the Company's ability to fulfil its commitments or meet its obligations in the ordinary course of business as there is no pay-out resulting from the proposed Capital Reduction and it would be beneficial to all the Shareholders of the Company as the same shall ensure that the total paid of equity share capital of the Company post reduction and consolidation of capital of the Company will represent the actual available capital of the Company.

Further, financial statements for the Financial Year ended 31st March, 2026 reflect accumulated losses (i.e., debit balance of profit and loss account) of Rs. 1,22,41,849/-. Such accumulated losses have substantially wiped off the value represented by the share capital.

Considering the future prospects of growth and value addition to the Company and its Shareholders, it is proposed to re-align the relationship between its capital and assets in accordance with Section 66 of the Companies Act, 2013 read with the National Company Law Tribunal (Procedure for reduction of share capital of Company) Rules, 2016 and other applicable provisions of the Companies Act, 2013 (to the extent applicable), by writing-off the accumulated losses of Rs. 1,12,75,880/- reflecting in the Audited financial statements of the Company as on March 31, 2026 against the paid-up share capital of the Company, to have a rational structure which is commensurate with its remaining business and assets.

It is proposed to effect the reduction of share capital by reducing the number of equity shares from 1,02,50,800 Equity Shares of Rs. 2/- each to 46,12,860 Equity Shares of Rs. 2/- each and subsequently effect the consolidation from 46,12,860 Equity Shares of Rs. 2/- each to 9,22,572 Equity Shares of Rs. 10/- each.

To effect such reduction and consolidation in Issued, Subscribed and Paid-Up Equity Share Capital the shareholders of the Company on the record date will get 9 (Nine) equity share of Rs.10/- (Rupees Ten Only) each fully paid-up against 100 (Hundred) equity shares of Rs.2/- (Rupees Two Only) each fully paid up.

The fractional entitlements, if any, shall be rounded off to one share and the same would be allotted to the respective shareholders. Simultaneously, the increase in the number of shares due to rounding off will be forgone by Mr. Venkata Rama Mohan Raju Jampana, Promoter of the Company thus keeping the paid-up Share Capital intact to Rs. 92,25,720 /- (Rupees Ninety Two Lakhs Twenty Five Thousand Seven Hundred Twentyonly).

2. RATIONALE AND PURPOSE OF THE SCHEME

- a) By virtue of article 59 of Articles of Association of the Company, the Company is authorized to reduce its share capital in any manner and in accordance with the provisions of the Act.
- b) After evaluating various options, the Board of Directors at their meeting held on 31.08.2026 had decided to reduce the paid-up capital of the Company. In this regard the Board has decided to reduce the 55% of paid-up share capital of the Company by cancelling and extinguishing 55% of the paid-up value of the shares. Furthermore, the reduction of capital would not in any way have any adverse effect on the Company's ability to honour its commitments or meet its obligations in the ordinary course of business.
- c) In the above context, the Company proposes to write off Accumulated Losses of Rs. 1,12,75,880/- (Rupees One Crore Twelve Lakhs Seventy Five Thousand Eight Hundred and Eighty only) reflecting in the audited financial statements of the Company as on March 31, 2026 with the balance appearing in Share Capital Account under the provisions of Section 66 of the Companies Act, 2013 would accordingly be applicable in respect of such reduction.
- d) The reduction envisaged under this Scheme would not in any way have any adverse effect on the Company's ability to honour its commitments or meet its obligations in the ordinary course of business and that the reduction of share capital shall not cause any shareholder to hold in

fraction shares, if any caused by the reduction of share capital and subsequent consolidation, the same shall be rounded off to one share and the same would be allotted to the respective shareholders. Simultaneously, the increase in the number of shares due to rounding off will be forgone by Mr. Venkata Rama Mohan Raju Jampana, Promoter of the Company thus keeping the paid-up Share Capital intact to Rs. 92,25,720/- (Rupees Ninety-Two Lakhs Twenty-Five Thousand Seven Hundred Twenty only).

- g) Hence, the Board of Directors believe that in order to present a fair position of the affairs of the Company, the most practically and economically efficient option available to the Company would be to utilize the balance lying in the Share Capital to the extent of writing off the Accumulated Losses of the Company, subject to the confirmations / sanctions of the requisite majority of the Shareholders of the Company and the NCLT and such other appropriate authority, as may be applicable.

3. Effective Date and Operative Date:

This reduction of capital shall be effective from the Effective Date i.e. the date on which certified copies of the order of the respective Hon'ble NCLT under Section 66 of the Companies Act, 2013 and other applicable provisions of the Companies Act, 2013 and rules framed there under, if any, are filed with the Office of the Registrar of Companies, Ministry of Corporate Affairs

4. Effects of the Scheme:

a) As on the effective date,

- the Issued, Subscribed and Paid -up capital of the Company shall stand reduced from Rs. 2,05,01,600/- (Rupees Two Crores Five Lakhs One Thousand Six Hundred Only) divided into 1,02,50,800 (One Crore Two Lakhs Fifty Thousand Eight Hundred Only) equity shares of Rs. 2/- (Rupees Two only) each to Rs. 92,25,720/- (Rupees Ninety-Two Lakhs Twenty-Five Thousand Seven Hundred Twenty only) divided into 46,12,860 (Forty-Six Lakhs Twelve Thousand Eight Hundred Sixty Only) equity shares of Rs. 2/- (Rupees Two only) each.
- The reduction shall be effected by cancelling and extinguishing 56,37,940 (Fifty-Six Lakhs Thirty-Seven Thousand Nine Hundred Forty Only) equity shares of Rs. 2/- (Rupees Two only) each held by the equity shareholders of the Company on a proportionate basis, without payment of any consideration. The amount arising from such reduction of paid-up share capital aggregating to Rs. 1,12,75,880/- (Rupees One Crore Twelve Lakhs Seventy-Five Thousand Eight Hundred Eighty Only) shall be utilised to write off the accumulated losses of the Company thereby presenting a true and fair view of the financial position of the Company, on the terms and conditions set out in the Scheme.
- Subsequent to the Reduction, remaining 46,12,860 (Forty-Six Lakhs Twelve Thousand Eight Hundred Sixty) equity shares of Rs. 2/- each, fully paid-up, shall be consolidated such that every 5 (Five) equity shares of ₹2/- each shall be consolidated into 1 (One) equity share of ₹10/- (Rupees Ten) each, fully paid-up.
- Further, Post Reduction and consolidation the paid-up equity share capital of the Company shall be Rs. 92,25,720 divided into 9,22,572 Equity Shares of Rs. 10 each, fully paid-up

- b) The Scheme is only for reduction of Share Capital of the Company and it does not envisage transfer or vesting of any properties and /or liabilities to or in favor of the Company.
- c) The proposed reduction of Paid-up Share Capital of the Company by way of writing off the Accumulated losses against the amount lying in the Share Capital Account of the company will be for the benefit of the Company, its creditors, Shareholders and all the concerned stakeholders. Such reduction will not cause any prejudice to the creditors of the Company. The reduction of Share Capital Account would not in any way adversely affect the ordinary operations of the Company or the ability of the Company to honor its commitments or pay its debts in the ordinary course of the business.

5. OBJECTS/ BENEFITS ARISING OUT OF THE SCHEME

- a) Under this Scheme, if approved, the books of the Company would better represent its financial position which would help the Company position itself better in the market and undertake business activities efficiently. This would be value accretive to the Shareholders as well, as their holdings would yield better results.
- b) The adjustment / set off of the balance in Share Capital Account would not have any impact on the shareholding pattern.
- c) The reduction of Share Capital Account in the manner proposed would enable the Company to have a rational structure which is commensurate with its business and assets.
- d) The Scheme of reduction, after full implementation, will result in making the Company's balance sheet leaner and downsized.
- e) The proposed Scheme would be for the overall benefit of the Company, its creditors, its Shareholders and all other stakeholders.
- f) The Scheme, if approved, would provide greater flexibility to the Company in raising funds either from the capital market or from any bank/ financial institutions in the form of equity or debt, depending on the business needs of the Company.

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of M/s. Notes forming part of the financial statements**A. General information**

Hindustan Bio Science Limited ("The Company") was incorporated under the Companies Act, 1956 as a public limited on December 16, 1991. The company is engaged in the manufacturing and sale of pharmaceutical products.

B. Basis of preparation of financial statements**B.1 Statement of Compliance**

These financial statements of the Company have been prepared in accordance with the Indian Accounting Standards ("Ind AS") notified under the Companies (Indian Accounting Standards) Rules 2015 as amended by Companies (Indian Accounting Standards) (Amendment) Rules, 2018 and the relevant provisions of the Companies Act, 2013.

These financial statements were authorized for issue by the Company's Board of Directors.

B.2 Basis of preparation and presentation

These financial statements have been prepared on the historical cost convention and on an accrual basis, except for the following material items in the statement of financial position:

- Certain financial assets and liabilities are measured at fair value;
- Employee defined benefit assets/(liability) are recognized as the net total of the fair value of plan assets, plus actuarial losses, less actuarial gains and the present value of the defined benefit obligation;
- Long term borrowings are measured at amortized cost using the effective interest rate method.

B.3 Functional and presentation currency

The financial statements are presented in Indian rupees, which is the functional currency of our Company. Functional currency of an entity is the currency of the primary economic environment in which the entity operates.

1.1 Operating cycle

All the assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013.

Assets:**An asset is classified as current when it satisfies any of the following criteria:**

- a) it is expected to be realized in, or is intended for sale or consumption in, the Company's normal operating cycle;

- b) it is held primarily for the purpose of being traded;
- c) it is expected to be realized within twelve months after the reporting date; or
- d) it is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting date.

Liabilities:

A liability is classified as current when it satisfies any of the following criteria:

- a) it is expected to be settled in the Company's normal operating cycle;
- b) it is held primarily for the purpose of being traded;
- c) it is due to be settled within twelve months after the reporting date; or
- d) the Company does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting date. Terms of a liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments do not affect its classification.

Current assets/ liabilities include the current portion of non-current assets/ liabilities respectively. All other assets/ liabilities are classified as non-current.

2. Significant accounting policies**2.1 Revenue recognition**

Revenue is recognized when the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is probable, the associated costs can be estimated reliably, there is no continuing management involvement with the goods and the amount of revenue can be measured reliably. Revenue is measured at the fair value of the consideration received or receivable, net of taxes and applicable trade discounts and allowances.

Interest income

Interest income from a financial asset is recognized when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on, time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

2.2 Foreign Currency Transactions:

Foreign currency transactions are initially recorded at the exchange rates prevailing on the transaction date. All revenues denominated in foreign currency are translated at the exchange rate prevailing on the date of inward remittance. The consequent exchange gains/ losses arising there from are transferred to the statement of profit and loss. All foreign currency

denominated monetary assets are translated at the exchange rate prevailing at the Balance Sheet date and the exchange gains/losses resulting there from are transferred to the statement of profit and loss.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognized in profit or loss in the period in which they are incurred.

2.3 Taxation

Income tax expense consists of current and deferred tax. Income tax expense is recognized in the income statement except to the extent that it relates to items recognized directly in equity, in which case it is recognized in equity.

Current tax

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the reporting date, and any adjustment to tax payable in respect of previous years.

Deferred tax

Deferred tax is recognized using the balance sheet method, providing for temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Deferred tax is not recognized for the following temporary differences: the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit; differences relating to investments in subsidiaries and jointly controlled entities to the extent that it is probable that they will not reverse in the foreseeable future; and taxable temporary differences arising upon the initial recognition of goodwill. Deferred tax is measured at the tax rates that are expected to be applied to the temporary differences when they reverse, based on the laws that have been enacted or substantively enacted by the reporting date. Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets, and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities, but they intend to settle current tax liabilities and assets on a net basis or their tax assets and liabilities will be realized simultaneously.

A deferred tax asset is recognized to the extent that it is probable that future taxable profits will be available against which the temporary difference can be utilized. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realized.

2.4 Earnings per share

The Company presents basic and diluted earnings per share (“EPS”) data for its ordinary shares. Basic EPS is calculated by dividing the profit or loss attributable to ordinary shareholders of the Company by the weighted average number of ordinary shares outstanding during the period. Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares, which includes all stock options granted to employees.

2.5 Property, plant and equipment

Recognition and measurement

Items of property, plant and equipment are measured at cost less accumulated depreciation and accumulated impairment losses, if any. Cost includes expenditures that are directly attributable to the acquisition of the asset. The cost of self-constructed assets includes the cost of materials and other costs directly attributable to bringing the asset to a working condition for its intended use. Borrowing costs that are directly attributable to the construction or production of a qualifying asset are capitalized as part of the cost of that asset.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

Gains and losses upon disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and are recognized net within “other (income)/expense, net” in the income statement.

The cost of replacing part of an item of property, plant and equipment is recognized in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its cost can be measured reliably. The costs of repairs and maintenance are recognized in the income statement as incurred.

Items of property, plant and equipment acquired through exchange of non-monetary assets are measured at fair value, unless the exchange transaction lacks commercial substance or the fair value of either the asset received or asset given up is not reliably measurable, in which case the asset exchanged is recorded at the carrying amount of the asset given up.

Depreciation

Property, plant and equipment is depreciated under straight line method after considering the useful life's and residual values at the time of acquisition and reviewed at end of each financial year. The cost and related accumulated depreciation are eliminated from the financial statements upon sale or retirement of the asset and the resultant gains or losses are recognized in the statement of profit and loss

2.6 Cash flow statements

Cash flows are reported using the indirect method, where by profit/(loss) before tax is adjusted for the effects of transactions of a non- cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated based on the available information.

2.7 Inventories

The fair value of inventories acquired in a business combination is determined based on its estimated selling price in the ordinary course of business less the estimated costs of completion and sale, and a reasonable profit margin based on the effort required to complete and sell the inventories.

2.8 Impairment of non-financial assets

The carrying amounts of the Company's non-financial assets, other than inventories and deferred tax assets are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated.

The recoverable amount of an asset or cash-generating unit (as defined below) is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or the cash-generating unit. For the purpose of impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or groups of assets (the "cash-generating unit").

An impairment loss is recognized in the income statement if the estimated recoverable amount of an asset or its cash-generating unit is lower than its carrying amount. Impairment losses recognized in prior periods are assessed at each reporting date for any indications that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortization, if no impairment loss had been recognized. Goodwill that forms part of the carrying amount of an investment in an associate is not recognized separately, and therefore is not tested for impairment separately. Instead, the entire amount of the investment in an associate is tested for impairment as a single asset when there is objective evidence that the investment in an associate may be impaired.

An impairment loss in respect of equity accounted investee is measured by comparing the recoverable amount of investment with its carrying amount. An impairment loss is recognized in the income statement, and reversed if there has been a favorable change in the estimates used to determine the recoverable amount.

2.9 Employee benefits

Short-term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognized for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

Defined contribution plans

The Company's contributions to defined contribution plans are charged to the income statement as and when the services are received from the employees.

2.10 Provisions

A provision is recognized if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. Where discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

2.11 Contingent liabilities & contingent assets

A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

Contingent assets are not recognized in the financial statements. However, contingent assets are assessed continually and if it is virtually certain that an inflow of economic benefits will arise, the asset and related income are recognized in the period in which the change occurs.

2.12 Financial instruments

Initial recognition

The Company recognizes financial assets and financial liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issues of financial assets and financial liabilities that are not at fair value through profit or loss, are added to the fair value on initial recognition.

Subsequent measurement

- Financial assets at fair value through other comprehensive income

A financial asset is subsequently measured at fair value through other comprehensive income if it is held with a business model whose objective is achieved by collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. Further in cases where the Company had made an irrevocable election based on its business model, for its investments which are classified as equity instruments, the subsequent changes in fair value are recognized in other comprehensive income.

- **Financial liabilities**

Financial liabilities are subsequently carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to short maturity of these instruments.

2.13 Critical accounting judgements and key sources of estimation uncertainty :

In the application of the Company's accounting policies, which are described in note 3, the management of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The following are the areas of estimation uncertainty and critical judgements that the management has made in the process of applying the Company's accounting policies and that have the most significant effect on the amounts recognized in the financial statements:

Provision and contingent liability

On an ongoing basis, Company reviews pending cases, claims by third parties and other contingencies. For contingent losses that are considered probable, an estimated loss is recorded as an accrual in financial statements. Loss Contingencies that are considered possible are not provided for but disclosed as Contingent liabilities in the financial statements. Contingencies the likelihood of which is remote are not disclosed in the financial statements. Gain contingencies are not recognized until the contingency has been resolved and amounts are received or receivable.
